Hope you all are warm!

At the mid-January Board of Governors' Meeting, I got some good leads for future columns but please, if you have any ideas for me don't be bashful about my e-mail address, above.

This week I went to the County Office Building in Ellicott City where I live to pay my Maryland Watershed Protection and Restoration Fee also known as the Rain Tax. While I had paid my property taxes back in the Fall, at the end of the year I received corrected tax bills because the Rain Tax had not been included in the original bill. I wanted to get my payments in since they carried a whopping 18% interest rate even though they arrived as I mentioned quite by surprise. I spoke to Pat Dimartino in the cashier's office to learn that there has been a tremendous volume of inquiry and consternation about these bills and which in some vague degree are apparently capped for certain tax payers in Howard County at \$10,000. That said, the Rain Tax for Columbia Mall this year is \$63,480; a Clarksville family-run hardware store got a bill for around \$4,300. Wow. This is Howard County's attempt to raise \$18 million this year I was told by Lindsay DeMarzo, a clean water specialist in the office of Environmental Sustainability. This is Howard County's proportion of the 14.8 billion total the watershed fee/Rain Tax is intended to clean up (only) the Chesapeake Bay. Maryland's Atlantic Coastal bays are not included notwithstanding legislation only a few years back that declared, in essence, that the coastal bays should receive the same sort of protection and the attention that the Chesapeake Bay deserves.

The third person I spoke to while at the Howard Building, payin' my fees, err, taxes, was Jeff Meyers who prepares legislation for the Howard County Council.

Interestingly, the 10 jurisdictions (Baltimore City and nine counties selected because they all have MS4 permits), were left each to devise their own taxes-or are they fees? Howard, Harford, and Anne Arundel Counties have similar schemes. Frederick and Carroll also have similar schemes: one of those two counties decided that a good amount would be one cent, the other decided it would be 0 cents. The other five jurisdictions are evidently quite an assortment.

The upshot of all this is that this tax remains controversial. Oops! Did I mean to say fee? Either way there remains some vitality as I understand it to repeal this matter and go back to the drawing board. Since every county in the state drains into the Chesapeake (including Worchester as the Hudson family story taught us) should the burden be shared state wide, and not only on the 10 jurisdictions? An alternative method to help pay for Bay cleanup has been the so called "flush tax". Please note: of the 67 waste water treatment plants in Maryland, 40 of them are located in the 10 jurisdictions singled out for the Rain Tax.

Trivia factoid: One of those 40 plants located right here in Maryland, The Blueplains Wastewater Treatment Plant, is said to be the largest in the world.

If you like, you can go on an on-site tour which is given once a week to nonschool groups. Alternatively, you can go on line and take a "virtual tour" however that one will only not cover all 5 of yours senses: for a couple of those senses, that might be a good thing. A real good thing.

Now for a quick plug and a short bed-time story. The plug: good book by Oceanographer Curtis Ebbesmeyer- Flotsametrics and the Floating World: How One Man's Obsession with Runaway Sneakers and Rubber Ducks Revolutionized Ocean Science. He was the fellow who discovered that right and left Nike sneakers will pile up separately on different beaches, has another chapter discussing how navigators in Christopher Columbus' day were aware that they, as a group, were familiar with unusual watercraft that would be encountered on the high seas. As it turns out, they were dead Eskimos still in their kayaks, having come from the direction of Greenland and so on: a chapter on burial at sea, a chapter on sailboats that traveled across entire oceans, the skipper either dead or missing and so on. One chapter discusses the eleven major gyres of trash in the various oceans (It's the one in the Pacific bigger than Texas that seems to get all the attention, however.)

And now the bed-time story that the last sentence leads to. Recently, when I was in the Midwest to visit my daughter, Annie, in Chicago I saw an article where the Great Lakes are also being polluted with plastic, but from the opposite side of the concern about the great gyres in the ocean. A concern of the plastic in the great ocean gyres is that it will break down to the point and in such quantity that it will interfere with ocean organisms that will mistake it for food, and get messed up somehow from ingesting it.

The problem now that has been discovered in the Great Lakes is that micro beads of perfectly spherical micro plastics contained in personal care products such as facial and body washes and toothpastes are going directly through waste water treatment plants and collecting in the Great Lakes. The worry is of course that the baby guppies and whatnot will ingest this stuff and not be happy and will fail to thrive or alternatively, may grow up to be a bigger fish that goes on up the food chain to us and somehow comes to make us unhappy. Oh well, time to go to bed.

PENNSYLVANIA

With the winter recess over things are starting to pick up in PA. Searching for information on the NJ side of the Delaware wasn't as informative in the way of updates.

In late January Harry Campbell, Pennsylvania Director for the Chesapeake Bay Foundation (CBF) testified before the Pennsylvania House Environmental

Resources & Energy Committee to stress the importance of streamside forested buffers as a means for improving and protecting the Commonwealth's most sensitive and pristine waterways.

The Committee met to discuss House Bill 1565, which proposes to remove the existing riparian forest buffer requirement for land developments that require erosion and sedimentation control and post-construction storm water permits when occurring alongside Pennsylvania's scientifically determined "Special Protection Waters."

Pennsylvania's rivers and streams with the most outstanding water quality, reflected in both water quality chemistry and aquatic life, are afforded the greatest degree of protection, and are designated either High Quality (HQ) or Exceptional Value (EV). Collectively, these streams are often referred to as Special Protection Waters.

For nearly two decades Pennsylvania has invested in restoring streamside forests. Protecting existing forested buffers, while at the same time reestablishing lost buffers, is an integral component of Pennsylvania's efforts under the Chesapeake Bay Clean Water Blueprint.

"Without protected and restored streamside forests, the Commonwealth will have difficulty meeting targeted pollution reductions as established in the state Watershed Implementation Plan, and meeting our clean water goals will be far more challenging and costly," Campbell continued.

The Many Benefits of Buffers: Research has continuously indicated that forested buffers provide significant removal of nonpoint source pollution, such as nitrogen, sediment, and phosphorus.the leading causes of stream degradation in Pennsylvania and the major pollutants impacting the Chesapeake Bay.

Forested buffers also help to reduce the costs of treating drinking water. Research has shown that trees play a vital role in maintaining the quality of the water entering drinking water treatment plants and, therefore, reduce the costs of treatment.

A riparian buffer can help to prevent property damage because they capture, absorb, and store amounts of rainfall up to 40 times greater than disturbed soils, like agricultural fields or construction sites, and 15 times more than a typical suburban lawn.

HARRISBURG, Pa. (Jan. 23) . The Pennsylvania Fish and Boat Commission (PFBC) voted at its quarterly meeting today to create a voluntary \$1 youth fishing license and to dedicate the revenue generated from it to programs to increase youth fishing participation.

Increasing youth and family participation in fishing, boating, and conservation programs has always been part of our strategic plan, said PFBC Executive Director John Arway. This goal responds to the fact that the percentage of children and young adults ages 6 to 15 who fished in Pennsylvania in 2010 was only 24 percent, as compared to 37 percent in 2005 and 41 percent in 1995. We want to continue to refine and develop programs to engage kids..

A youth license also provides an added benefit when it comes to federal funding, which accounts for approximately 25 percent of the PFBC's budget. For every youth license sold, the PFBC will receive approximately \$5 in federal revenue

from the U.S. Fish and Wildlife Service's Sport Fish Restoration Act program, which provides funds to states based on a formula that includes the number of licenses a state sells.

If just 25 percent of those 367,000 children were to purchase a voluntary \$1 license, it would result in more than \$550,000 in revenue for the Commission to invest in youth programs.

The voluntary youth license will be available beginning Feb. 1 from all licensing agents and online through the PFBC's Outdoor Shop. With a \$1 agent fee and a \$0.70 transaction fee, the total cost to purchase the license will be \$2.70.

Ocean dunes in state parks are closed to sledding, snowboarding in fact they are closed to anyone for any purpose

due to their fragility: With several snow storms under our belts and more to come, DNREC's Division of Parks and Recreation is asking the public to help protect the dunes in Delaware's ocean parks by reminding residents and visitors that dunes should not be used for sledding or snowboarding.

In fact, except for marked crossings, dunes are closed year-round to pedestrian traffic and activities in Cape Henlopen and Delaware Seashore state parks. Dunes contain fragile habitat and provide protection for the beaches and the communities that border them. Recent storms have already caused some damage this winter. So Please, don't tramp or travel on the Dunes area.

Hunters take advantage of Snow Goose Conservation Order starting Feb. 1 About 6 years ago, I spoke to this matter at a Federal Regional Hearing held in Mt. Holly, New Jersey by the Federal Fish and Wildlife Service. Luckily what proponents had to say had an impact to change the law concerning Canada Geese and Snow Goose populations. The Delaware Division of Fish and Wildlife is once again implementing an annual Snow Goose Conservation Order, which began in 2009 as part of an Atlantic Flyway-wide effort to reduce the population of greater snow geese. Snow goose numbers have reached levels that are now causing extensive damage to their breeding grounds in the Canadian Arctic as well as the wetlands and agricultural areas where they winter over in the Mid-Atlantic, including Delaware. The 2014 Conservation Order to harvest snow geese will open on Saturday, Feb. 1 and run through Friday, Feb. 7, then will reopen Monday, Feb. 10 and run through Saturday, April 12.

The Conservation Order is a separate season open only for snow geese which occurs after the regular waterfowl hunting seasons close. It was created with the intent of using hunting as a game management tool to reduce and stabilize the greater snow goose population. Last year, an estimated 9,965 snow geese were harvested by more than 700 hunters who participated in Delaware's Conservation Order.

During the Conservation Order, hunters will be able to pursue snow geese every day except Sunday. Use of unplugged shotguns and electronic calls are allowed, with legal shooting hours starting a half-hour before sunrise and extended to a

half-hour after sunset; there are no daily bag and possession limits. All other federal and state hunting regulations apply.

The Conservation Order will be closed on Saturday, Feb. 8, for a special statewide waterfowl hunting day for youths and non-ambulatory disabled hunters. Regular snow goose hunting is also allowed on this day for all legally licensed waterfowl hunters in Delaware, but the special harvest methods described above are not allowed and the regular-season daily bag limit of 25 snow geese will be in effect on this day.

Most state wildlife areas will open to hunting during the Conservation Order beginning Monday, Feb. 3, to avoid conflict with Delaware's firearm deer seasons. Wildlife areas in New Castle and Sussex counties will be open on a first-come, first-serve basis with no registration required, except at Assawoman Wildlife Area, where hunters must self-register at the Assawoman check station. In Kent County, individual sign-in will be required at Woodland Beach, Little Creek and Ted Harvey wildlife areas. Sign-in will not be required at Blackiston, Milford Neck, or Norman G. Wilder wildlife areas. To avoid conflicts with the spring 2014 wild turkey season, snow goose hunting will be prohibited on state wildlife areas after Friday, April 4. Bombay Hook and Prime Hook national wildlife refuges will be closed to hunting during the Conservation Order.

To participate in the Conservation Order, hunters must obtain a free Snow Goose Conservation Order permit number by registering at https://egov.delaware.gov/HTR. Participants are also required to have a valid Delaware hunting license or a Maryland resident hunting license, a 2013-14 Delaware waterfowl stamp and a Delaware Harvest Information Program (HIP) number, with the HIP available at the website above. A federal waterfowl stamp is not required.

Once registered for the snow goose Conservation Order permit, hunters are required to keep this permit number in their possession while hunting and to report their hunting activity and success to the Division of Fish and Wildlife by Thursday, May 1 via website at https://egov.delaware.gov/HTR; hunters may also report by phone at (302) 735-3600.

Project to improve Navigation of Murderkill River at Bowers Beach

This project will improve safety and navigable access of the Murderkill River and nourish the eroding shoreline at South Bowers Beach. The project involves dredging approximately 45,000 cubic yards of material from the federal navigation channel in the river and the beneficial reuse of the clean dredged sand to widen the beach at South Bowers. The dredging of the Murderkill River will ensure safe navigation for the boating public, while the sand protects homes, infrastructure and habitat from the impacts of coastal storms. Nearly threefourths of the dredged material is suitable beach-fill quality sand. The remaining unsuitable dredged material will be placed in an approved offshore disposal site.

The communities along the Delaware Bayshore, like Bowers and South Bowers, enjoy a deep and rich maritime heritage and remain home to the state's commercial and recreational fishing vessels. Fishing is very important to the local economy and vital to the economy of the state.

According to American Sportfishing Association, the economic value of recreation fishing in Delaware is almost \$150 million annually, while the commercial fishing industry's annual value is estimated at about \$10 million.

However, commercial and recreational boaters are experiencing difficulties navigating the state's waterways due to the buildup of silt and sediment along main channels.

Many of the state's waterway management obligations, including dredging and channel marking in federally authorized waterways, have defaulted to DNREC in recent years. In the absence of federal funding, the State has stepped in and dredged the Murderkill River four times since the 1980's.

The project is expected to cost \$950,000 with funding provided by the State Legislature. An appropriation in the amount of \$627,000 was provided in the FY 2013 Bond Bill, with the balance being paid through DNREC's Shoreline and Waterway Management Bond Bill appropriation.

US Coast Guard Rescue 21: The latest report from the USCG is that Rescue 21 (R21) is completely operational along the entire Atlantic, Pacific and Gulf coasts. All Sectors of the US are either

under Conditional Acceptance or Final Acceptance. The exception to this is Alaska and the Western Rivers, which are still undergoing testing or design review.

R21 is a major overhaul of the Coast Guard ship to shore communications system involving their Search & Rescue operations. R21 is an advanced maritime computing, command, control and direction finding communications system which was created to better locate mariners in distress and save lives. R21 can now more accurately identify the location of callers in distress via new towers that generate lines of bearing to the source of VHF radio transmissions, thereby significantly reducing search time.

In order to fully benefit from R21, the VHF radio and the GPS should be connected and the Maritime Mobile Service Identity (MMSI) info should be entered into the VHF radio. By doing this, when the Digital Selective Calling (DSC) button is pressed your coordinates from the GPS and the MMSI data are transmitted and the Coast Guard will know your exact location and have the MMSI data you entered.



Over 70 Years Old, "Magenta Line" To Get a Safer Route With Help From Boaters

ALEXANDRIA, Va., January 27, 2014 -- It's over 70 years old, a thin magenta-colored line appearing on over 50 different navigational charts covering the Atlantic Coast and Gulf, snaking along the route of the Intracoastal Waterway. Now, thanks to NOAA's Office of Coast Survey and a public-private partnership with Active Captain, an interactive cruising guidebook, NOAA will be updating the "magenta line" on all of its newly-issued navigational charts to help keep boaters in safe waters. Boat Owners Association of The United States (BoatUS) submitted comments on the proposal to NOAA, who had initially proposed removing the line entirely. However, responding to BoatUS' and other boaters' comments, NOAA will tap into users of Active Captain to update the route in an on-going effort that will benefit the boating community.

"Some boaters had assumed the magenta line, which was last updated in 1935, was a precise route through safe waters," said BoatUS Government Affairs Senior Program Coordinator David Kennedy. "However, over time the forces of nature made the line inaccurate as shoals shifted and underwater topography changed, leading some boats into shallows, over dangerous obstructions, or even into land. We thank NOAA for a change of course in keeping the magenta line, listening to boaters and coming up with a creative public-private partnership that recognizes the value of this important guide to navigation."

The magenta line appears in charts covering all Intracoastal waters, and is essentially two distinct routes along the eastern US and Gulf Coasts totaling about 3,000 miles in length. Said Captain Shep Smith, chief of NOAA's Coast Survey's Marine Chart Division, "Today's decision to reinstate the magenta line is not a quick fix. It will take at least three years to fix problems that were 70 years in the making."
