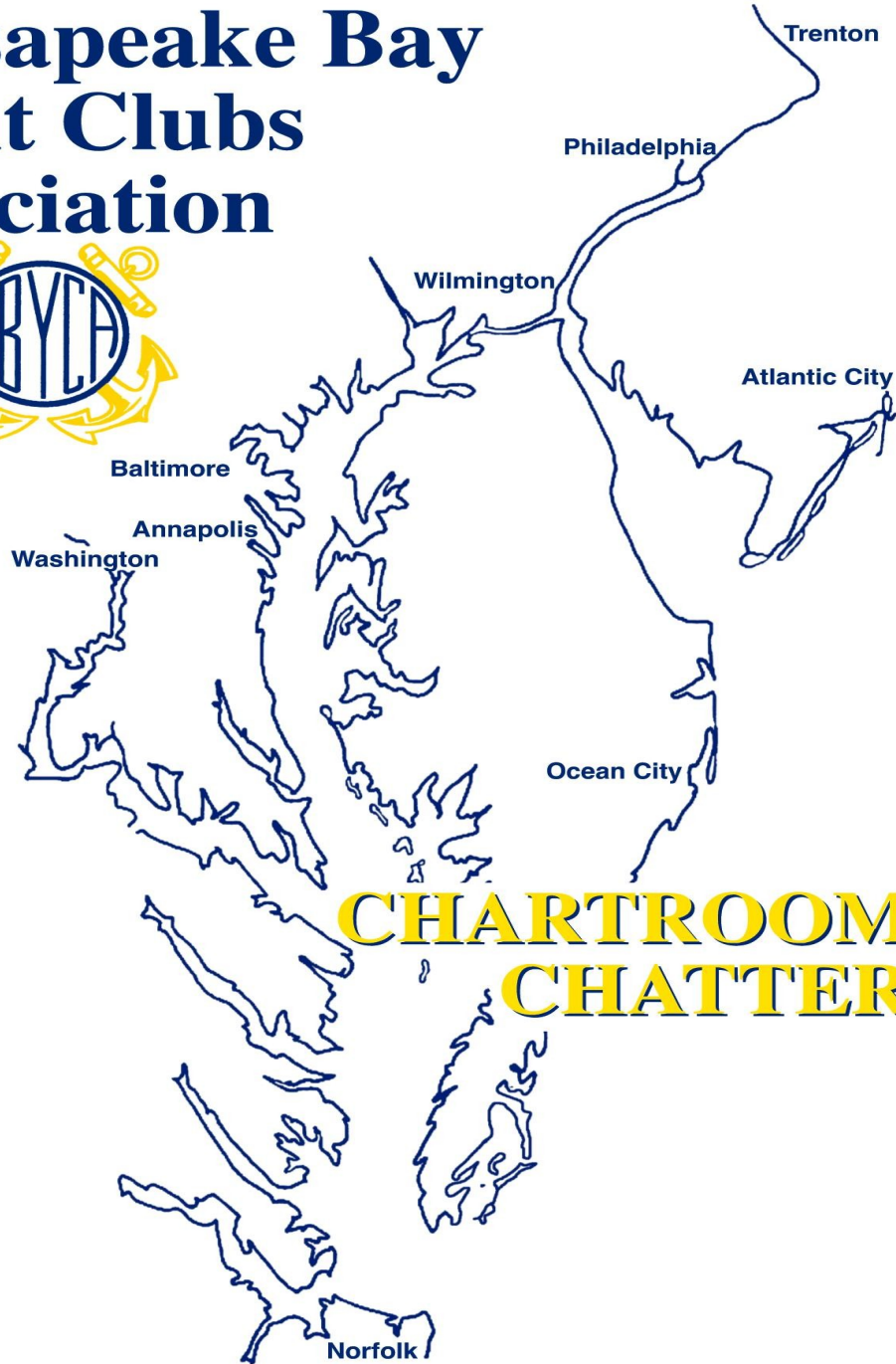

Solomons Island Yacht Club is one of those places most of us have visited repeatedly. If you haven't been there in a while, you need to put it back on your bucket list. Cruising clubs stop by on vacation cruises to soak up the friendliness, wonderful waterfront views and cold drinks from their magnificent bar.

I had not been there since their big remodeling project in 2010. The club found ways to make a great place even better! Wow! The enlarged upstairs dining/party room features a wonderful fireplace along with an open truss ceiling and water views of Ma Leg Island, that triangular piece of land off Jane's Point at the entrance of Back Creek. The upstairs bar was also expanded. On the ground floor the expanded lower level bar and Captains' Lounge are great places to visit and enjoy what may be CBYCA's largest collection of visiting club burgees. Solomons Island Yacht Club boasts 430 burgees on overhead display like stalactites.



Every flag is referenced and recorded in a bar notebook they proudly show to anyone who's curious. Their collection includes burgees from 35 states and 42 foreign countries. One of them is a burgee from the oldest Yacht club in the world, the Royal Cork Yacht Club (Cork, Ireland), established in 1720.

When Solomons Island hosted the March CBYCA Board of Governors Meeting, their main pier was under reconstruction, so coming in to visit by boat or dinghy will be even better. ## **Pennsylvania/Delaware Legislative Report**

### **Pennsylvania**

#### **Legislation:**

Pennsylvania now has 2 House bills and 1 Senate bill (all identical) which set fishing license fees through 2023. We have 1 House bill and 1 Senate bill (both identical) which allow the



Fish and Boat Commission to set its own fees as well as the registration and titling fees for boats. Of the bills that would permit the commission to set fees **SB 30** is moving along well through various committees. If SB 30 becomes law changes will take effect July 1, 2017.

Currently, only the General Assembly can set and alter licensing fees for hunting, fishing, and boating activities. The commissions say this method stifles their ability to fund their activities and to both keep up with mandated cost increases within the agencies and carry out their essential missions since they rely almost exclusively on fees for support. While the legislation would allow the commissions to set their licensing fees through regulation, the General Assembly would retain the oversight authority to, by joint resolution, override the fee increase. Similar legislation failed to clear the General Assembly last session, dying in the House upon the legislature's recess.

Other bills of interest are **HB 675** which would permit therapeutic recreation programs to operate without the requirement for fishing licenses and **HB 813** which would allow seniors with valid and lawfully issued fishing licenses from other states to fish in Pennsylvania.

### **Elcon and the Department of Environmental Protection (for clubs on the Delaware River):**

The Phase I portion of the Elcon application for a commercial hazardous waste treatment and storage facility proposed for Falls Township, Bucks County was found to be in conformance with the exclusionary siting criteria regulations on November 12, 2015. As of March 2, 2017 The Pennsylvania Department of Environmental Protection (DEP) has received the Phase II portion of Elcon Recycling Services, LLC's (Elcon). DEP has 90 days to determine if the application is considered administratively complete. Throughout the review process, DEP will conduct public outreach through public meetings and hearings, information sheets, status updates and DEP's website. At this time, it is still too early to confirm a schedule of in-person opportunities over the duration of the review.

### **FYI Pennsylvania Fish and Boat Commission (PFBC):**

#### **Mentored Youth Trout Days March 25<sup>th</sup> and April 8<sup>th</sup>**

This is the fourth year for the popular program that provides adult mentors with an opportunity to take kids fishing before the traditional rush of the regional and statewide opening days of trout season. Last year, more than 25,600 kids signed up to participate, either by purchasing a \$1 voluntary youth fishing license or by acquiring a free mentored youth fishing permit. For more information click

#### **First Day of Trout Season April 1<sup>st</sup> in Southeast Counties.**

The PFBC's "great white fleet" of hatchery trucks has been busy since late February stocking

Pennsylvania's waterways with a fresh supply of brook, brown and rainbow trout. In addition to these fish, the PFBC plans to stock about 8,700 trophy golden rainbow trout that weigh an average of 1.5 pounds and measure at least 14 inches long. Also, PFBC cooperative nurseries run by sportsmen's clubs across the state will add another 1 million trout to waters open to public angling. Check the PFBC website above for license information.

### **Public Meetings Scheduled to Discuss Susquehanna River Bass Proposal:**

The PFBC has scheduled three public meetings to collect comments on a proposal to remove the closed season on Smallmouth and Largemouth Bass at the middle and lower Susquehanna and lower Juniata rivers. The proposal – outlined at the January quarterly business meeting – would allow anglers to practice catch-and-release fishing for bass from May 1 through mid-June. However, tournaments would remain banned during the bass spawning period from mid-April to mid-June period, like all other waters of the Commonwealth. Catch-and-release regulations for bass would remain in place throughout the rest of the year.

**President Trump Orders EPA to Rescind Controversial “Waters of the U.S.” Rule**

As reported by NMMA, President Donald Trump issued an [executive order](#) directing the Environmental Protection Agency (EPA) and the U.S. Army Corps of Engineers to start a formal review of the “Waters of the United States” (WOTUS) rule, which expands the number of waterways federally protected under the Clean Water Act. The executive action to fix the WOTUS rule came after a highly contentious fight which pitted agriculture, environmental, real estate developers and manufacturing interests. The WOTUS rule was drafted during the Obama administration and broadened the definition of such things as "tributary" and also toughened controls over "adjacent waters." Several states and industry groups challenged WOTUS and a federal court eventually issued a stay to halt its implementation. Agriculture groups have been critical of the rule, claiming farmers could lose ranch or farmland because of the regulations. Environmental and conservation groups supported the expansion as a way to tackle agricultural runoff that impacted water quality and safe drinking water

**RFS Reform Act Reintroduced to Prevent E15 Damage**

Last week, Congressman Goodlatte (R-VA), Jim Costa (D-Calif.), Steve Womack (R-Ark.), and Peter Welch (D-Vt.) [reintroduced Renewable Fuel Standard \(RFS\) Reform Act \(H.R. 1315\)](#). The RFS Reform Act eliminates corn-based ethanol requirements, caps the amount of ethanol that can be blended into conventional gasoline at 10 percent, requires the EPA to set cellulosic biofuels levels at production levels, and decreases the total volume of renewable fuel that must be contained in gasoline sold or introduced into commerce for years 2017-2022. NMMA and NBF applaud these efforts at ensuring a safe and reliable fuel supply remains in place for boaters and is optimistic that Congress will tackle RFS Reform to better protect consumer choice.

Efforts by the EPA to increase the amount of ethanol in the fuel supply, up to 15 percent ethanol by volume (E15) is dangerous for boaters. Boaters are prohibited from using amounts above E10, but the EPA has done nothing to ensure the required fuel source for millions of boats and off-road equipment remains available. In 2016, renewable volume obligations numbers set levels of ethanol that will decimate the availability of ethanol free gas, a fuel type heavily demanded by many consumers.

### **Coast Guard Rescues 2 Aboard Sinking Boat Near Chesapeake Bay Bridge Tunnel, Virginia**

The Coast Guard rescued two people aboard a boat near the third island at the Chesapeake Bay Bridge Tunnel.

Coast Guard Station Little Creek received notification at approximately 3:15 p.m. that a 23-foot boat had struck an underwater rock with two people aboard and was taking on water. Station Little Creek diverted a 45-foot Response Boat-Medium (RBM) crew already in the vicinity training and launched a second RBM crew. The first crew arrived on scene at approximately 3:20 p.m. with the second arriving shortly after. Both RBM crews transferred dewatering pumps to the vessel.

The two RBM crews escorted the boat to Lynnhaven Marine Boatel in Virginia Beach where it was moored up at 4:15 p.m.

“We were lucky to already be training in the area” said Petty Officer 2nd Class Geoffrey Wells, coxswain in the second responding RBM. “Station Little Creek is always ready to maintain a quick response to mariners in distress.”

### Delaware River Range Changes

The March [Fifth District Local Notice to Mariners](#) reports that the USCG has proposed changes to the following front and rear range lights on the Delaware River:

- Marcus Hook Range: Relocate and rebuild the front and rear lights; Rename and renumber the lateral Aids to Navigation
- Bellevue Range: Rename and renumber the lateral Aids to Navigation
- Chester and Eddystone Ranges: Rename and renumber the lateral Aids to Navigation
